#### Mistake #10- Missing the Statute of Limitations

The Statute of Limitations, in Arizona, is a two year time limit on every personal injury action. In fact, there are many statutes that are as little as 180 days. The Statue of Limitations forces plaintiffs to either settle their case or file a lawsuit by a certain date. The goal is a necessary one, to prevent someone from suing a defendant 25 years after a crash. Unfortunately, some people are misled by their insurance agencies as to what the proper actions are needed to be taken to file, therefore, missing the deadline. Here are some tips to help avoid this circumstance:

- 1. Your claim is not filed when you tell your insurance company about your situation. You must file a lawsuit with an Arizona Court. The deadline requires other documents to be filed as well.
- 2. If a claim is filed after the Statute window, insurance agencies do not give an injury victim any legal rights.
- 3. You do not have to wait until any treatment is complete before filing your claim. Often insurances companies will tell you that and "trick" you into going over the Statute.

# VALENTINE'S DAY CAKE POPS

1 box of cake mix 1 can of frosting 1 bag of melting chocolates Sprinkles and Sticks

#### **DIRECTIONS**

- Bake your cake according to the boxed directions. Once finished baking let cool for about 20 minutes.


