# LEGAL RUMBLES

## Understanding Gap Insurance

What happens if you are in an accident and your bike is wrecked? If the wreck is so bad that the bike is a total loss, your insurance coverage might only cover what the bike is worth, and not necessarily what you still owe the lending company.

That's where Gap Insurance coverage comes in. It's an optional coverage that pays the difference between what your primary insurance pays and what you still owe on the bike. It's good to have if you owe more than your bike is worth.

It's also important to have collision coverage on your bike, especially if it's leased or financed. Collision insurance pays out

if your bike is damaged during a crash with another vehicle or another object. It also pays if you are involved in a rollover accident that doesn't involve anyone else.

However, it's also important to have a knowledgeable team helping you if you are involved in an accident. Gap insurance typically requires you to file paperwork within a certain time or it won't pay. It also won't cover storage charges, towing charges or other costs, while your collision insurance will. 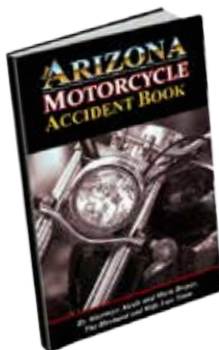
