A Little About The Law:

Arizona Full Coverage Insurance: Is it Enough?

We receive far too many phone calls from people who believe they have "full coverage" insurance on their car. If you look at any Arizona statute, there is no definition of full coverage. We have seen full coverage mean nothing more than the minimum limits allowed under the law, and we have seen full coverage mean every possible type of insurance that can be purchased. We have also seen everything in between when it comes to Arizona insurance company secrets.

Do not accept the fact that you have "full coverage" auto insurance. After a serious personal injury accident, you can find that the agent who sold you the "full coverage" insurance actually sold you a "bill of goods." In other words, in the effort to try to get your business, the insurance agent reduced the coverage you had but still told you that you had "full coverage." Then, when it's time to make the claim, the insurance adjuster (very different than the insurance agent and not trying to get your business but often trying to prevent you from receiving full and fair compensation for your injuries) explains to you that you do not have uninsured motorist coverage or underinsured motorist coverage, which you need to protect yourself when making a Phoenix automobile accident and injury claim.

If you find yourself in this position or you know someone who is making an insurance claim but they are being told that they do not have full coverage, do not accept this at face value. Call us and we will review your policy!

DID YOU KNOW?

Did you know that if your child is hurt by another child it may be possible to make a claim against the homeowner's insurance of the home the child lives in?

Did you know that if you live with a blood relative even if you are not on their insurance policy the relative's policy might cover your injuries?

Did you know that a photo radar ticket requires service of a summons for it to be effective?

Did you know that there are specific regulations for nursing home facilities?

Did you know that \$10,000 is the minimum amount of coverage allowable by law and that if someone causes damage to your car in an accident they may only have \$10,000 in insurance to fix your car?

Did you know that you only have 180 days to file a Notice of Claim with any city or government entity if they are the party that caused the negligence.?

Pet food?

The dog and cat dish are within a baby's crawl zone. Your pet is a favorite family member. So of course your baby is going to be curious about what the kitty or puppy are eating. "Pet food carries the same risk as Play-Doh and crayons," an expert says. "It's not going to be toxic. But if it's the right size and shape to block the airway, you do need to be concerned." Your child will be fine if a little pet food or saliva-laden water has made it from the animal bowl to her mouth, but you may want to buy food that's in smaller chunks until your child is older.

Also, beware of watch batteries. If a child swallows a watch battery they could receive very serious injuries or even may die from the chemicals released from the battery.
